To complete your application, you will need a scanned copy (in PDF, JPG or GIF format) of the front of your driving licence and your insurance certificate. Please note we are unable to accept the insurance schedule, renewal notice or other documents as a substitute.

You will also need to provide a licence check code which you can obtain from the DVLA.

- Select 'Start now'
 Enter your licence number, National Insurance number and postcode, tick the declaration box and select 'View now'
- Your licence details should appear
- At the top right-hand corner of the page, click 'Get your check code'
 Select 'Get a code'
- Please note the check code is case sensitive.
